# DISABILITY SERVICES AND SUPPORT

### SEVERE MEDICAL HEALTH CONDITION

Resources are provided to schools to assist staff with students who frequently require emergency life preserving intervention during school hours. Eligibility for this indicated group is considered on a case by case basis and includes serious prolonged medical conditions such as severe epilepsy, refractory epilepsy or unstable diabetes.

#### **Eligibility Requirements**

The following evidence is required to be submitted in order for Disability Services and Support to confirm eligibility for funding:

#### **Epilepsy**

- For an initial application, a recent diagnosis from a medical practitioner that is no greater than 6 months old is required stating the diagnosis of epilepsy (severe or refractory in nature), whether it is controlled or uncontrolled on medication and the type and frequency of seizures.
- A current medical emergency response plan for the student that is signed by a medical professional and parent/carer that:
  states the diagnosed medical condition (severe or refractory in nature)
  - type and frequency of seizures
    specifies the symptoms indicating a medical emergency and the steps the school is to follow

Please note: continued eligibility is dependent on the frequency, type and intensity of the seizures. The level of resourcing is guided by how the seizures impact on the student's ability to access the curriculum.

#### **Diabetes**

1. A diagnosis of Type 1 diabetes from a medical practitioner

Please note: The resource is provided to implement programs designed to assist students to self-manage their condition.

Resourcing for students with diabetes is up to the end of Year 2 and may only be considered case by case after Year 2 in extenuating circumstances. A resource may be provided for a limited period. This would include if the student has been newly diagnosed and cannot self-manage, or if it can be demonstrated that changes have occurred in the student's condition (e.g. they move onto an insulin pump) that have necessitated renewed programs for developing independence.

School principals are responsible for maintaining updated medical action plans for Diabetes at the school in accordance with the Student Health Care Policy.

#### **Other Severe Medical Health Conditions**

1. For an initial application a recent diagnosis from a medical practitioner that is no greater than 6 months old is required
